

Where should household waste be thrown away?

I have moved to Matsudo city, but where should household waste be thrown away?

To the person who has moved to Japan (Matsudo city) from a foreign country, "What is a repository?"

Welcome to Matsudo city!

The trash which has gone out at the respective houses (It's called household waste.) is being collected every area at Matsudo city. The, the place where they're gathered is "repository". A city office collects and punishes the household waste taken out in a repository.

When using a repository, how should it be done?

When doing moves and using a repository of household waste, to depend on kind of repositories changes.

When collective housing in the apartment apartment (It's called an exclusive repository.)

- (1) it's confirmed in a proprietary company and a management society whether there is an exclusive repository in the collective housing you live.
- (2) the occasion with the exclusive repository is used along a rule. When not having that, which repository does whether I can use it check in a proprietary company and a management society?
- (3) when using a repository besides the exclusive repository, I get the user's consent by making reference to the following "in case of detached house" and use it along a rule.

When it's detached house (It's called a general repository.)

- (1) the general repository the real estate agent who mediated, the previous resident and the person living in a neighborhood can use is checked.
- (2) when beginning use, agreement of the person using the repository is needed. A greeting also serves both, and I'll confirm whether I can use it.
- (3) after consulting community associations when a repository can't be used by the reason for the number's of users being the limit, other repositories are considered.
- (4) it's used along a rule in each repository.



To the person who has moved to Japan (Matsudo city) from a foreign country, "What is community associations?"

There is a community in the area called community associations in Matsudo city. This is the group carrying on various activity to make the area it's easier to live where while cooperating between the people who live in the neighborhood.

There are management in a household waste repository and recycling activity that cleaning and plastic bottles, etc. are collected as an example of activity.

What does a rule have?

The most important rules are a [way to separate of household waste and a rule of how to take it out](#). A repository isn't the trash can everyone may throw everything away anytime. A city collects only a way to separate and the household waste which obeyed rules of how to take it out in the day of the week when a decided person has been decided. Trash of a rule violation will be not being collected and be being left.

A rule of "burden of trash accumulation BOX purchase expense" and "burden of a trash duty" etc. is also besides the way to separate of household waste and how to take it out (This is called "appropriate burden"). A decision depends on a repository, so to the administrator who is each repository for more information (proprietary company and community associations), Contact Us, please.

Why is it checked in a town assembly and a council?

There are about 18,000 repositories in Matsudo city, and I'm requesting upkeep in a repository of everyone of the user, an administrator or an owner. It's community associations that you're doing the coordination.
