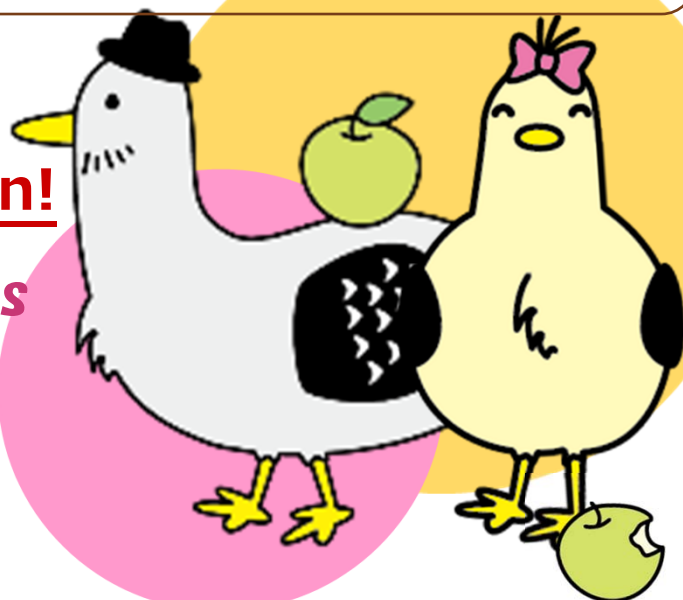

Requirements (All of the following requirements must be met)

- ☐ The applicants are a married couple whose marriage registration was submitted and accepted **between January 1, 2025 and March 31, 2026**.
- ☐ The couple's total income from **January 1 to December 31, 2024** was **less than 4 million yen**. * If the applicant is currently repaying scholarship loans, the amount of annual repayment will be deducted from the couple's household income during calculations.
- ☐ Both spouses are **42 years old or below** as of the date of their marriage.
- ☐ The address of the newlyweds at the time of their application is the residence considered in the application.
- ☐ The applicants have not received a similar type of subsidy from the national or local government under other laws or regulations.
- ☐ The applicants must be willing to live in Matsudo City for at least two years from the date the subsidy is provided.
- ☐ None of the applicants are a member of organized crime groups, as defined in Article 2, Item 3 of the "Act on Prevention of Unjust Acts by Organized Crime Group Members".

Subsidized Expenses

※ All of the following payments must be made **between April 1, 2024 and March 31, 2025**

● Housing Acquisition Expenses	The cost of purchasing a building for a house upon marriage (Construction and/or purchase of a new house, purchase of a used house)
● Housing Rental Expenses	Expenses for housing rented upon marriage <u>Deposit, Key money, Agency fee, Rent & Common service fee</u> (up to two months)
● Moving Expenses	Expenses paid to a moving company for moving upon marriage (This does not apply if you moved yourselves, or asked friends to help you)
● Renovation Costs	Expenses for repairs, expansion, reconstruction, and renewal of facilities in order to maintain or improve the function of the house out of the renovation upon marriage

The documents you need to prepare differ depending on the type(s) of expenses to be subsidized. **Please check the City's Website and the checklist on our website for details.**
